

May 21, 2018

Appanoose County Board of Supervisors met in regular session May 21, 2018 at 9:00 A.M. in the Boardroom of the Courthouse. Present: Mark Waits, Chairman, Neal Smith and Linda Demry, Boardmembers. Absent: None.

Meeting started with the Pledge.

Demry motioned to approve the agenda with deletion of "pending dram" for Bessie's Barn. Seconded by Smith. All voted aye.

Smith motioned to approve the minutes of the May 7, 2018 meeting. Seconded by Demry. All voted aye.

Jeff Kulmatycki from Hawk Insurance and Willene White from County Risk Management Services, Inc. spoke to the board about ICAP/IMWCA insurance pool benefits. At 9:15 A.M. Waits interjected to go to public hearing.

Smith motioned to open the public hearing for road reclassification of a portion on 561st Street. Seconded by Demry. All voted aye. County Engineer, Matt Haden, stated all adjoining landowners have signed a petition to reclassify a portion of 561st Street, SE of Moulton from a Level "A" to a Level "C". Demry motioned to close the public hearing. Seconded by Smith. All voted aye. Demry motioned to approve Resolution #2018-19. Seconded by Smith. All voted aye.

Resolution #2018-19

RESOLUTION FOR REDUCED LEVEL OF MAINTENANCE TO AREA SERVICE "C" ROAD

WHEREAS, Appanoose County desires to classify certain roads on the area service system in the County to provide for a minimal level of maintenance and access by means of a gate or barrier; and WHEREAS, the County, after consultation with the County Engineer, has the authority to specify certain roads within the County as Area Service "C" roads pursuant to Iowa Code Section 309.57; and WHEREAS, the only persons who will have access rights to the roads shall be:

1. The owner, lessee, or person in lawful possession of any adjoining land,
2. The agent or employee of the owner, lessee or person in lawful possession of any adjoining land,
3. Any peace officer,
4. Any magistrate,
5. Any public employee whose duty is to supervise the use or perform maintenance of the road,
6. Any agent or employee of any utility located upon the road.

WHEREAS, the minimal level of maintenance will be as follows:

1. Blading. Blading or dragging will not be performed on a regular basis.
2. Snow and Ice Removal. Snow and ice will not be removed, nor will the road surface be sanded or salted on a regular basis.
3. Signing. Except for load limit posting for bridges, signing shall not be continued or provided. ALL AREA SERVICE LEVEL C ROADS SHALL BE IDENTIFIED WITH A SIGN AT ALL POINTS OF ACCESS TO WARN THE PUBLIC OF THE LOWER LEVEL OF MAINTENANCE.
4. Weeds, Brush and Trees. Mowing or spraying weeds, cutting brush and tree removal will not be performed on a regular basis. Adequate sight distances will not be maintained.
5. Structures. Bridges and culverts may not be maintained to carry legal loads. Upon failure or loss, the replacement structure will be appropriate for the traffic thereon.
6. Road Surfacing. There will be no surfacing materials applied to Area Service System C Roads on a regular basis.
7. Shoulders. Shoulders will not be maintained on a regular basis.
8. Crown. A crown will not be maintained on a regular basis.
9. Repairs. There will be no road repair on a regular basis.
10. Uniform Width. Uniform width for the traveled portion of the road will not be maintained.
11. Inspections. Regular inspections will be not conducted.

THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF APPANOOSE COUNTY that this County does hereby establish the road described as an Area Service "C" road, with restricted access and a minimal level of maintenance.

That portion of 561st Street, beginning at the Eastern most border of Appanoose County then heading west for approximately 0.093 miles. This road is located in the NE Corner of Section 25, T68N, R16W. Resolution adopted this 21st day of May, 2018.

Demry motioned to approve the liquor licenses for Bessie's Barn. Seconded by Smith. All voted aye.

Smith motioned to approve a fireworks permit for J&M Displays. Seconded by Demry. All voted aye.

CDS Coordinator, Stephanie Koch, attended suicide training and has asked the Region to open it up for others. The crisis house opened May 14th and does not require you to go through the ER first. The legislature passed a bill that requires mobile crisis in every county. Appanoose already has this and will be looking into see how it is working.

Haden, updated the board on the secondary road projects. 458th St Bridge is closed to install some helper beams. The Brinegar Bridge on 437th will be getting ready to start construction. Crews have been working on edge repair and the FM rock project is done. Smith asked if Haden has started ordering parts to repair the grader in house. Haden stated they would do everything but the transmission in house. The current mechanic has never rebuilt a transmission. Haden likes the idea of having a warranty from Zeigler. Smith wants to save the county money and have it done in house.

Demry motioned to approve payroll and prisoner room & board transfer. Seconded by Smith.

Phil Visser, Conservation Director, said the sidewalks are done and work will now start on the septic.
