May 7, 2018

Appanoose County Board of Supervisors met in regular session May 7, 2018 at 9:00 A.M. in the Boardroom of the Courthouse. Present: Mark Waits, Chairman, Neal Smith and Linda Demry, Boardmembers. Absent: None.

Meeting started with the Pledge.

Smith motioned to approve the agenda. Seconded by Demry. All voted aye.

Demry motioned to approve the minutes of the April 16, 2018 meeting. Seconded by Smith. All voted aye.

Mike Craver stated he was told the annexation will create an island and will look into it. Demry motioned to table the voluntary annexation. Seconded by Smith. All voted aye.

Demry motioned to approve the liquor licenses for Honey Creek Resort State Park and the Pale Moon. Seconded by Smith. All voted aye.

Smith motioned to approve the beer licenses for Elliott's General Store. Seconded by Demry. All voted aye.

Smith motioned to open the public hearing for the FY18 County Budget Amendment. Seconded by Demry. All voted aye. The amendment was for an increase in Secondary Roads budget for rock and capital projects (bridge work), debt service for invoice fees on the RASWC loan, and a correction to the Secondary Roads transfer. The amendment totaled \$400,500. Demry motioned to close the budget amendment public hearing. Seconded by Smith. All voted aye. Demry motioned to approve the FY18 County Budget Amendment. Seconded by Smith. All voted aye.

Demry motioned to open the public hearing for ZOMA 0418-01. Seconded by Smith. All voted aye. Zoning Administrator, Jon Foster, stated ZOMA 0418-01 was to change from agricultural to residential to allow for a garage to be built. Ordinance number ZOMA 0418-01 was read. Smith motioned to close the public hearing for ZOMA 0418-01. Seconded by Demry. All voted aye. Demry motioned to approve Ordinance Number ZOMA 0418-01. Seconded by Smith. All voted aye. Demry motioned to waive the second and third readings. Seconded by Smith. All voted aye.

Smith motioned to open the public hearing for Resolution #2018-18. Seconded by Demry. All voted aye. County Engineer, Matt Haden, stated kids mudding, tear up the road and all landowners signed the petition requesting the reclassification. Demry motioned to close the public hearing for Resolution #2018-18. Seconded by Smith. All voted aye.

Demry motioned to approve Resolution #2018-18. Seconded by Smith. All voted aye.

Resolution #2018-18

RESOLUTION FOR REDUCED LEVEL OF MAINTENANCE TO AREA SERVICE "C" ROAD

WHEREAS, Appanoose County desires to classify certain roads on the area service system in the County to provide for a minimal level of maintenance and access by means of a gate or barrier; and

WHEREAS, the County, after consultation with the County Engineer, has the authority to specify certain roads within the County as Area Service "C" roads pursuant to Iowa Code Section 309.57; and

WHEREAS, the only persons who will have access rights to the roads shall be:

1. The owner, lessee, or person in lawful possession of any adjoining land,
2. The agent or employee of the owner, lessee or person in lawful possession of any adjoining land,
3. Any peace officer,
4. Any magistrate,

5. Any public employee whose duty is to supervise the use or perform maintenance of the road,
6. Any agent or employee of any utility located upon the road.

WHEREAS, the minimal level of maintenance will be as follows:

1. Blading. Blading or dragging will not be performed on a regular basis.
2. Snow and Ice Removal. Snow and ice will not be removed, nor will the road surface be sanded or salted on a regular basis.
3. Signing. Except for load limit posting for bridges, signing shall not be continued or provided. ALL AREA SERVICE LEVEL C ROADS SHALL BE IDENTIFIED WITH A SIGN AT ALL POINTS OF ACCESS TO WARN THE PUBLIC OF THE LOWER LEVEL OF MAINTENANCE.
4. Weeds, Brush and Trees. Mowing or spraying weeds, cutting brush and tree removal will not be performed on a regular basis. Adequate sight distances will not be maintained.
5. Structures. Bridges and culverts may not be maintained to carry legal loads. Upon failure or loss, the replacement structure will be appropriate for the traffic thereon.
6. Road Surfacing. There will be no surfacing materials applied to Area Service System C Roads on a regular basis.
7. Shoulders. Shoulders will not be maintained on a regular basis.
8. Crown. A crown will not be maintained on a regular basis.
9. Repairs. There will be no road repair on a regular basis.
10. Uniform Width. Uniform width for the traveled portion of the road will not be maintained.
11. Inspections. Regular inspections will be not conducted.

THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF APPANOOSE COUNTY that this County does hereby establish the road described as an Area Service "C" road, with restricted access and a minimal level of maintenance.

That portion of 555th Street which is currently classified as a Level B, beginning at the intersection of 210th Ave and 55th Street then heading east approximately .50 miles more or less to the end of the county ROW.

Demry motioned to approve a fireworks permit for Viking Pyrotechnics Inc. Seconded by Smith. All voted aye.

Demry motioned to approve the purchase of 4 flags on the inside of the courtyard from the Chamber. Seconded by Smith. All voted aye.

Waits read a letter of support for Chariton Valley Electric Cooperative's Community Connect grant application. Smith motioned to approve sending the letter. Seconded by Demry. All voted aye.

Demry motioned to approve the tax suspension for parcels: 290251002500000, 290251002510000, 290251002520000, & 290251008450000. Seconded by Smith. All voted aye.

Demry motioned to approve the hiring and deputy appointment of Jewell Cohrs in the Auditor's Office beginning 5/7/18 at a starting salary of \$33,508.05 a year. Seconded by Smith. All voted aye.

Haden, updated the board about hail damage on Secondary Roads buildings. He received a quote for \$20,000 from Commercial Roof Coatings to recoat the metal roofs. To tape the joints it will be another \$5,000 and then have a 10 year warranty. He is getting quotes for the office building which is covered with full replacement cost. Smith recommended getting the joints taped. There was discussion

regarding selling and purchasing equipment. Haden wishes to sell T5 & T6 and purchase a 30' gooseneck trailer. Waits motioned to sell T5 & T6. Motion died for lack of second. Demry told Haden to purchase the trailer then get approval to sell T5 & T6. There is also a shop truck and Ford tractor he wishes to sell and purchase a newer shop truck. Howard was asked to contact state auditors regarding gifting the tractor to conservation. The M5 road grader will cost \$85,000 to repair from Ziegler. A used machine with 5,000 hours will cost \$105,000. Demry & Smith are not in favor and want the old machine fixed.

RESOLUTION FOR ROAD RECLASSIFICATION PUBLIC HEARING

Appanoose County

WHEREAS, a request has been made with the Appanoose County Board of Supervisors asking that action be taken to reclassify a section of Appanoose County Secondary Road from a Level A to a Level C, described as follows:

That portion of 561st Street, beginning at the Eastern most border of Appanoose County then heading west for approximately 0.093 miles. This road is located in the NE Corner of Section 25, T68N, R16W.

NOW THEREFORE BE IT RESOLVED that a hearing on the proposed reclassification will be held in the Board Room, Appanoose County Courthouse, 201 N 12th, Centerville IA 52544 at 9:15 AM on Monday May 21st, 2018 in accordance with Iowa Code Chapter 306.

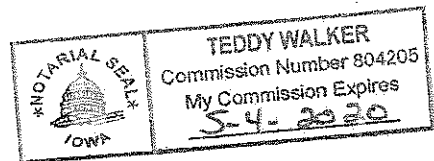

**RESOLUTION FOR REDUCED LEVEL OF MAINTENANCE TO AREA SERVICE "C"
ROAD**

Appanoose County Resolution No. _____

WHEREAS, Appanoose County desires to classify certain roads on the area service system in the County to provide for a minimal level of maintenance and access by means of a gate or barrier; and

WHEREAS, the County, after consultation with the County Engineer, has the authority to specify certain roads within the County as Area Service "C" roads pursuant to Iowa Code Section 309.57; and

WHEREAS, the only persons who will have access rights to the roads shall be:

- (1) the owner, lessee, or person in lawful possession of any adjoining land,
- (2) The agent or employee of the owner, lessee or person in lawful possession of any adjoining land,
- (3) any peace officer,
- (4) any magistrate,
- (5) any public employee whose duty it is to supervise the use or perform maintenance of the road,
- (6) any agent or employee of any utility located upon the road.

WHEREAS, the minimal level of maintenance will be as follows:

1. Blading. Blading or dragging will not be performed on a regular basis.
2. Snow and Ice Removal. Snow and ice will not be removed, nor will the road surface be sanded or salted on a regular basis.
3. Signing. Except for load limit posting for bridges, signing shall not be continued or provided. ALL AREA SERVICE LEVEL C ROADS SHALL BE IDENTIFIED WITH A SIGN AT ALL POINTS OF ACCESS TO WARN THE PUBLIC OF THE LOWER LEVEL OF MAINTENANCE.
4. Weeds, Brush and Trees. Mowing or spraying weeds, cutting brush and tree removal will not be performed on a regular basis. Adequate sight distances will not be maintained.
5. Structures. Bridges and culverts may not be maintained to carry legal loads. Upon failure or loss, the replacement structure will be appropriate for the traffic thereon.
6. Road Surfacing. There will be no surfacing materials applied to Area Service System C Roads on a regular basis.

7. Shoulders. Shoulders will not be maintained on a regular basis.
8. Crown. A crown will not be maintained on a regular basis.
9. Repairs. There will be no road repair on a regular basis.
10. Uniform Width. Uniform width for the traveled portion of the road will not be maintained.
11. Inspections. Regular inspections will not be conducted.

THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF APPANOOSE COUNTY that this County does hereby establish the road described as an Area Service "C" road, with restricted access and a minimal level of maintenance.

That portion of 561st Street, beginning at the Eastern most border of Appanoose County then heading west for approximately 0.093 miles. This road is located in the NE Corner of Section 25, T68N, R16W.
