Appanoose County Board of Supervisors met in regular session November 20, 2017 at 9:00 A.M. in the Boardroom of the Courthouse. Present: Mark Waits, Chairman, Neal Smith and Linda Demry, Boardmembers. Absent: None.

Meeting started with the Pledge.

Waits mentioned the Silent Auction was open from 9:00 A.M. to noon.

Smith motioned to approve the agenda. Seconded by Demry. All voted aye.

Demry motioned to approve the minutes of the November 6, 2017 meeting. Seconded by Smith. All voted aye.

There were no public comments.

Smith motioned to approve the Family Farm, Homestead & Veteran tax credits. Seconded by Demry. All voted aye.

Demry motioned to approve the liquor license for Doggs RV and a refund for Wubbies Roadhouse. Seconded by Smith. All voted aye.

Demry motioned to set a public hearing for a Zoma Recommendation on 11/20/17 at 9:15 A.M. Seconded by Smith. All voted aye.

Demry motioned to wave the 2^{nd} and 3^{rd} readings of Zoma Ordinance 1017-01. Seconded by Smith. All voted aye.

Matt Haden, County Engineer, discussed the ADA transition plan. Public comments on the plan can be made in the Engineer's office until December 4th. The Board will need to approve a plan which includes budgeting so much per year to bring our facilities under compliance. Haden also discussed current projects including culverts and ditching. The hoe has been broken down and should be back this week. They will also start brush cutting.

CDS Coordinator, Stephanie Koch informed the board the Housing First project finished looking through applications. Calls will be made this week if they meet the qualifications. Stacey Veatch from Davis County heads up the program. They received 30 applications from the 4 counties.

Smith motioned to open the Zoma Ordinance 1017-02 public hearing. Seconded by Demry. All voted aye. Howard read Ordinance 1017-02. They would like to make a campground. Demry asked Zoning Administrator, Jon Foster, the Zoning board recommendation. Foster stated they approved it unanimously. Demry motioned to close the public hearing. Seconded by Smith. All voted aye. Demry motioned to approve Zoma Ordinance 1017-02. Seconded by Smith. All voted aye. Demry motioned to wave the 2nd and 3rd readings of Zoma Ordinance 1017-02. Seconded by Smith. All voted aye.

Waits asked Sheriff, Gary Anderson, how many inmates he had currently. Anderson stated 26 and all in neighboring counties. Jason Fraser stated he will keep the Facebook page up. It looked like \$7,600 was spent just last week without transportation costs included. A resolution accepting the canvass results was received from Ahlers & Cooney after canvass was completed. Demry motioned to sign the resolution with the election results. Seconded by Smith. All voted aye.
