Appanoose County Board of Supervisors met in regular session December 4, 2017 at 9:00 A.M. in the Boardroom of the Courthouse. Present: Mark Waits, Chairman, Neal Smith and Linda Demry, Boardmembers. Absent: None.

Meeting started with the Pledge.

Smith motioned to approve the agenda. Seconded by Demry. All voted aye.

Demry mentioned a paragraph needing to be stricken from the minutes. Demry motioned to approve the minutes of the November 20, 2017 meeting with the following passage stricken "Demry motioned to set a public hearing for a Zoma Recommendation on 11/20/17 at 9:15 A.M.. Seconded by Smith. All voted aye". Seconded by Smith. All voted aye.

There were no public comments.

Michael Johns for Appanoose County Railroad was not present.

Service Agency Chairman, Larry Bettis, was present to submit a formal recommendation from Service Agency that the county secure the land the jail was to be built on. Waits read Bettis' letter. Waits stated he wants input from the public in a public forum and be as transparent as possible. Bettis stated if the land was secured it would provide needed storage and he heard the state would be interested in renting space back. He received phone calls supporting the land purchase. Waits stated he too received calls in favor of it. Bruce Buttel stated the issue wasn't the land it was the jail was too big and too costly. Demry requested the paper ask for public input. Smith stated more input from the public is needed.

Demry motioned to approve the appointment of Drake Pasa to the Conservation Board. Seconded by Smith. All voted ave.

Matt Haden, County Engineer, presented a corrected public hearing resolution for road vacation for 272nd Ave. During the course of the last resolution, land changed hands. Demry motioned to set a public hearing regarding the road vacation of that portion of 272nd Ave beginning at the Northern right-of-way line of 528th St then bearing in a Northerly direction approximately 2,400 feet all lying in Sec 1, W Twp 68N Range 17W and the bridge located in the NE ¼ SW ¼ of Sec 1, Twp 68N, Range 17W be sold to Justin Doll for \$1 for December 18, 2017 at 9:15 A.M. Seconded by Smith. All voted aye.

- 3. That the Appanoose County Auditor is hereby authorized and directed to publish a notice of public hearing on said proposal to convey and sell property no less than four nor more than twenty days prior to that date of such hearing.
- 4. This resolution shall become effective upon its passage and publication.

Demry motioned to waive the 2nd and 3rd readings of Appanoose County Ordinance No. 45. Seconded by Smith. All voted aye.

Haden updated the board on Secondary Roads projects. They are finishing up ditching and culvert projects and will then focus on brush removal. The arm mower is out right now and the others will start once they are able. They have a loaner excavator from Cat while they wait for a part to come in. Waits requested Haden have a board member sign his timesheet every two weeks. Haden stated he will bring it up every two weeks. Smith said a stop sign is down on the Drake Avenue extension and requested Haden look at the shoulder. There is a 4-5 foot long shoulder drop.

CDS Coordinator, Stephanie Koch informed she has switched to Natel and has a new email address. Her phone is still currently with Windstream but will be looking to switch to Natel but retain the same phone number. The Housing First project is going well. There have been some new people not showing up to their appointments. The governing board met in Appanoose County last week and it went well. They are still waiting on RFP's for the stabilization homes that are due in January.
