I regret to inform you that I will be resigning my post as of 4/06/2019. We have taken the appropriate measures of advertising in the local paper for 2 separate listings on Wednesdays, it has also been posted on the Veterans Affairs Facebook page, and on the community board located in the Courthouse. The postings ran for 30 days in that time we received 10 resumes from Veterans and Non-Veterans alike. We conducted interviews on 3/21/2019 of which 9 people showed up. Out of the 9 people we selected Trista McClurg as the next Director of Veterans Affairs. Although Trista is not a Veteran herself she has had years of direct contact with friends and family members who were Veterans. Trista has also been a volunteer for us for the last 8 months and has done an outstanding job with the Veterans and is well received by them. I and the Commissioners feel that she was the best candidate to fill the position with her long history in this community and the contacts she has made in that time. I will continue to help her as long as she needs assistance in the transition but feel due to budget constraints that my last actual day should be sooner rather than later. I would like to acknowledge that if and when a Commissioners spot becomes available for the Veterans I would like to be considered for the position as I plan and wish to continue being involved and assisting our counties Veterans population.
