WHEREAS, Appanoose County, sometimes hereinafter referred to as the County, is a political subdivision duly incorporated, organized and existing under and by virtue of the Constitution and laws of the State of Iowa; and
WHEREAS, it is deemed necessary that the County should borrow the amount of \$7,500,000 as authorized by Section 423B.9(4), Code of Iowa as amended; and
WHEREAS, a proposal has been received from Northland Securities, Inc. of Minneapolis, Minnesota; and
WHEREAS, it is the intention of this Board of Supervisors to accept said proposal dated May 3, 2021.
NOW THEREFORE, BE IT RESOLVED, BY THE BOARD OF SUPERVISORS OF APPANOOSE COUNTY, STATE OF IOWA:

Section 1. That this Board of Supervisors does hereby accept the attached proposal of Northland Securities, Inc. of Minneapolis, Minnesota, and takes additional action to permit the financing.

Section 2. The Chairperson and County Auditor are authorized and directed to proceed on behalf of the County to enter into such proposal, to negotiate the final terms of the Bond Sale on a basis favorable to

the County and acceptable to the Purchaser, and to proceed to meet the conditions of this accepted proposal.

Skinner provided an update. The FM rock haul started this morning and will last approximately a month. FY21 bridge projects are complete. They will now start working on projects added to FY21 and FY22 projects. They are still waiting on steel. He traveled to Kansas City and selected five railcars for county projects (using the second vendor). A new driveway policy will be presented to the board for approval.

Public Comments: Centerville City Administrator, Jason Fraser, stated Treasury will issue their guidance on May 7th for the American Rescue Plan funds.

MEMORANDUM OF UNDERSTANDING

BETWEEN

THE U.S. ARMY CORPS OF ENGINEERS, KANSAS CITY DISTRICT

AND

APPANOOSE COUNTY, IOWA

FOR

RATHBUN DAM ROAD MAINTENANCE

MOU Number RDR00001

This is a memorandum of understanding (MOU) between the U.S. Army Corps of Engineers, Kansas City District (“NWK”) and Appanoose County, Iowa (“the County”). When referred to collectively, NWK and the County are referred to as the “Parties.”

1. BACKGROUND: NWK and the County have had an informal relationship for years, mutually supporting each other in the maintenance of Rathbun Dam Road. This MOU formalizes this relationship in order to ensure that this effective and mutually beneficial relationship continues.
2. AUTHORITIES:
 - a. NWK
 - i. DoDI 4000.19, December 16, 2020, subject: Support Agreements
 - b. The County
 - i. 2021 Code of Iowa, Chapter 28E
3. PURPOSE: To outline the agreements, understandings, and responsibilities associated with the maintenance of Rathbun Dam Road.
4. DEFINITIONS:
 - a. Rathbun Dam Road means the traveled surface of Rathbun Dam / Route J5T, from the intersection with J29 across the Rathbun Dam embankment to the North line of Section 30-T70N-R17W.
5. UNDERSTANDINGS OF THE PARTIES:
 - a. NWK

- i. NWK shall maintain the traveled surface of Rathbun Dam Road. In addition, NWK shall maintain shoulders and be responsible for all other maintenance within the Rathbun Dam Road right-of-way, including drainage, culverts, brush control, etc., as well as signing relating to Rathbun Dam.
- ii. The decision to close and physically barricade Rathbun Dam Road due to road conditions, weather conditions, flooding threat, or other similar emergency, shall be the sole responsibility of NWK.

b. The County

- i. The County shall be responsible for traffic marking and traffic signage on Rathbun Dam Road in accordance with the Manual on Uniform Traffic Control Devices.
- ii. The County may remove snow and/or ice from Rathbun Dam Road in the process of their regular snow removal operations, and subject to the County's current Snow and/or Ice Clearance Policy.

6. PERSONNEL: Each Party is responsible for all costs of its personnel, including pay and benefits, support, and travel. Each Party is responsible for supervision and management of its personnel.
7. COST OF PERFORMANCE. The cost for performing the duties outlined above shall be borne by the agency performing the service, or as stated.
8. INDEPENDENCE OF PARTIES. It is understood that the revenues for road improvements by the County are derived from past and future Property Tax receipts, Farm-to-Market Fund Allocations, and Road Use Taxes from the State of Iowa. The budget for the operation of Rathbun Dam is derived from the U.S. Army Corps of Engineers and other agencies of the United States Government. The Parties' revenues are understood to be independent of each other and no part of this agreement shall be construed as make such revenues available for use by the other party.
9. DAMAGES. Each agency shall be solely liable for any damages that may be awarded that result from the services performed by that agency as outlined in this agreement.
10. GENERAL PROVISIONS:

a. POINTS OF CONTACT (POCs). The following POCs will be used by the Parties to communicate matters concerning this MOU. Each Party may change its POC upon reasonable notice to the other Party.

c. FUNDS AND MANPOWER. This MOU neither documents nor provides for the exchange of funds or manpower between the Parties, nor does it make any commitment of funds or resources. No provision in this MOU will be interpreted to require obligation or payment of funds.

d. MODIFICATION OF MOU. This MOU may only be modified by the written agreement of the Parties, duly signed by their authorized representatives. This

MOU will be reviewed no less often than at the mid-point of its term and around the anniversary of its effective date in its entirety.

- c. DISPUTES. Any disputes relating to this MOU will, subject to any applicable law, Executive order, or DoD issuances, be resolved by consultation between the Parties.
- f. TERMINATION OF UNDERSTANDING. Either party may unilaterally terminate the MOU by providing at least 30 days written notice to the other Party. The MOU may be terminated at any time upon the mutual consent of the Parties.
- g. ENTIRE UNDERSTANDING. It is expressly understood and agreed that this MOU embodies the entire understanding between the Parties regarding the MOU's subject matter, thereby superseding all prior understandings of the Parties with respect to such subject matter.
- h. EFFECTIVE DATE. This MOU takes effect beginning on the day after the last Party signs.
- i. EXPIRATION DATE. This MOU expires on April 20, 2031.
- j. NO THIRD PARTY BENEFICIARIES. Nothing in this MOU, express or implied, is intended to give to, or will be construed to confer upon, any person not a party any remedy or claim under or by reason of this MOU and this MOU will be for the sole and exclusive benefit of the Parties.

Please accept this letter as formal notification of my intent to retire. My last day of work will be June 30, 2021 .





APPANOOSE COUNTY ENTRANCE AND DRIVEWAY POLICY

Revised: 03/09/2021

Be it resolved by the Board of Supervisors of Appanoose County that, effective this ____ day of _____, 2021, the following policy shall apply to all entrances and driveways serving as access to a secondary road under the jurisdiction of Appanoose County. This resolution supersedes any previous resolution on the same subject.

PURPOSE:

This policy is to establish Appanoose county's regulations for access to a secondary road under the jurisdiction of Appanoose County. The policy establishes requirements for the location and establishment of driveways, field entrances, and subdivision streets requested by property owners. It is designed to assure that adequate standards are maintained to allow safe access for persons entering upon secondary roads and providing safe highway use for the traveling public.

APPLICATION TO COUNTY ENGINEER:

Section 319.14 of the Code of Iowa requires that all persons shall not excavate, fill, or make a physical change within the right-of-way of a public road or highway without obtaining a permit from the highway authority having jurisdiction of the public road or highway.

All landowners, or their agents, tenants, or designees, who desire a new entrance, additional entrances, or to modify existing entrances, are required to obtain a permit for installation from the County Engineer prior to installation. Permits are available at no cost to the applicant.

Permit applications shall identify the road and locations where the work is proposed. The County Engineer will review the proposed location and applications to determine if it will comply with the location and construction requirements set forth by this policy. If the site satisfies all criteria, the County Engineer shall issue a permit and establish the culvert diameter and length. If the proposed location fails to meet all of the requirements, the Engineer may reject the applications, explaining the reasons for such action and advising what changes would be necessary to obtain approval.

RESPONSIBILITY OF WORK AND COSTS:

The property owner or tenant is responsible for the construction of all new entrances or modifications to existing entrances. This includes all materials and labor involved in the installation. All construction work shall conform to the requirements set by this policy. The property owner may purchase a corrugated metal pipe from Appanoose County if available for cost and have it delivered to the work site for no additional cost.

FINAL APPROVAL OF ENTRANCE:

After completion of a new entrance or modification of an existing entrance, the applicant shall notify the County Engineer, who shall inspect the entrance for conformance to this policy. The entrance will either be accepted or rejected. If the work is rejected, the applicant will be notified of the deficient work. All corrections must be completed before the entrance is put into use.

NONCONFORMING ENTRANCES:

Any nonconforming entrance built after the effective date (June 16, 2008) of the original Entrance and Driveway Policy Resolution, or this revised version of the resolution, may be removed by Appanoose County and the cost billed to the owner or party responsible for installing the entrance.

FUTURE MAINTENANCE:

Entrance culverts previously approved by the County Engineer (metal or concrete) will be maintained by the Appanoose County Road Department. The County will replace removed fill from pipe maintenance operations. Entrance surfacing (Asphalt, Concrete, or Aggregate) placement will be the responsibility of the property owner including replacement or repair of surfacing damaged when Secondary Road Department repairs or replaces the culvert. The County will not replace plastic culverts damaged by fire or otherwise melted. Plastic pipes are susceptible to damage from construction, maintenance, or fire and will not be maintained or replaced by the County.

ROADWAY CONSTRUCTION:

Any entrances removed for road construction will be replaced by the county at no cost to the owner. Existing entrance surfacing removed for construction will also be replaced by the county at no expense to the owner. At the request of the owner and with proper location approval, the County may construct additional entrances at the time of roadway construction with the owner responsible only for the cost of the culvert pipe.

LOCATION REQUIREMENTS:

All driveways, field or business entrances, and subdivision street intersections must meet minimum sight and stopping distance requirements:

1. 400' on gravel roads measured from the centerline of the entrance in each direction,
2. Spacing on pavements measured from the centerline of the entrance in each direction per Chapter 51 of current Statewide Urban Design and Specifications Design Manual (SUDAS).

The County reserves the right to make exceptions in extraordinary circumstances to the sight distance requirements at the discretion of the County Engineer where the exercise of sound and reasonable engineering judgment indicates that public safety will not be compromised.

Entrances will not be allowed within 100 feet from the end of a bridge and/or any guardrail installation

Entrances on a paved road will not be allowed within 250 feet from any intersecting road. Spacing and locations per SUDAS.

Entrances on a gravel road will not be allowed within 100 feet from any intersecting road.

CULVERT PIPE REQUIREMENTS:

If the location is approved, the County Engineer will determine if a culvert pipe is required, the size of the opening required, and the length of culvert pipe required. The required diameter and length for each culvert shall be based on the drainage area, entrance top width, entrance use, ditch depth, Annual Average Daily Traffic (AADT) and type of road surface being entered.

All Culvert pipes shall be approved by the County Engineer. Used culverts showing rust or having holes will not be approved. New pipe culvert pipe shall meet IDOT standards for entrance pipe and shall be a minimum of 15" diameter. The following new pipe materials are approved:

1. Corrugated metal pipe – 15" to 48" diameter (16 gauge), greater than 48" diameter (12 gauge)
2. Tied reinforced concrete pipe (2000D Class or better – no rejects)
3. PVC Pipe (Double-walled required) (Note: County will neither replace nor be responsible for damage to PVC pipe.)

CONSTRUCTION REQUIREMENTS:

1. Entrance Installation shall be according to IDOT & SUDAS specifications.
2. Permittee shall provide a certificate of insurance for the work being done, (naming the County as an additional insured on the Permittee's policy), to the County Engineer before the permit can be processed.
3. Minimum top width for a driveway or field entrance shall be 20 feet.
4. Sideslopes for entrances on rock roads shall be 3:1 minimum or a 6:1 minimum if no culvert is required, and sideslopes for entrances on paved roads shall be 8:1 minimum or as shown in SUDAS Chapter 51.
5. Entrances shall slope away from the road shoulder and shall be shaped to prevent water from the property draining onto the roadway.
6. Entrance shall be compacted by tamping or rolling.
7. No filling will be permitted in the right-of-way other than what is necessary to construct the proposed entrance.
8. No excavations will be made within the limits of the traveled portion of the roadway.

9. The construction, future repair, or maintenance of entrances shall be carried on in such a way as to not interfere with or interrupt traffic on the County road.
10. Private property may not be used to as to encumber the County right-of-way, or interfere with safety, comfort, and the use of County roadway users.
11. The permittee shall leave the road and the County right-of-way in as good condition as it was prior to construction.
12. Re-seeding of disturbed areas shall be with a seed mix approved by the IRVM Director or the County Engineer.
