Resolution 2021-32

WHEREAS: The Board of Supervisors is empowered under authority of Section 306 to maintain the roadways under their jurisdiction, and

WHEREAS: The County Engineer has completed (or has caused to be completed) a study for overhead lighting needs for the intersection of Iowa Highway 2 and 230th Avenue in Appanoose County which showed the location to meet or exceed the requirements of the Iowa Department of Transportation Intersection Lighting Warrants for Destination Lighting as a "T" intersection with entering traffic in excess of 1750 vehicles per day, and

WHEREAS: Alliant Energy Inc. is prepared to install such lighting in the southwest quadrant of said intersection

NOW, THEREFORE, BE IT RESOLVED by the Appanoose County Board of Supervisors that Alliant Energy Inc. is hereby requested to install standard intersection lighting on existing pole(s) within the Appanoose County Road Right-of-Way easement, in the southwest quadrant of the intersection of Iowa Highway 2 and 230th Avenue according to the terms expresses in the IPL Tariff regarding street lights

McGill motioned to approve the updated (new Supervisors) Memorandum of Understanding with Mercy One Centerville. Seconded by Kulmatycki. All voted aye.

Kulmatycki motioned to table appointing a medical examiner. Seconded by McGill. All voted aye.

McGill motioned to approve the FY21 Homestead and Military Credit applications. Seconded by Kulmatycki. All voted aye.

McGill motioned to set a Special LOSST Imposition Election for Moulton and Rathbun for November 2, 2021. Seconded by Kulmatycki. All voted aye.

County Engineer, Brad Skinner, provided an update to the board. T20 is done except signage and paperwork. Concrete for the box culvert on 110th St was poured on Friday and needs backfill. The two bridges that will be replaced with railroad flat cars have both been removed. The large excavator and a skid loader were down and have been repaired. The second dust application was done last week. The DOT let sealcoat project is expected mid-September and the shoulder project has a completion date of November 15th. Kulmatycki asked about the rough county intersections at the Hwy 5 repaving project. Skinner stated the final layer hasn't been added and he has spoken with them regarding the intersections. McGill stated he has received several calls from RRWA regarding the new permit process requiring board approval. Skinner stated the process hasn't changed and it is still the Engineer that approves and will find out where the misinformation is coming from.

Public Comments: Rex Harris & Brian Davis spoke to the board and the engineer about their displeasure regarding the gravel roads by their farms (rock runoff and crown). Skinner stated he hadn't been out in that area and will check into it.

McGill motioned for the auditor to place a RFP for county insurance (CY2022) in the paper with a due date of 10/6/2021 at 9 A.M. Seconded by Kulmatycki. All voted aye.

McGill motioned to adjourn. Seconded by Kulmatycki. All voted aye.

The Board adjourned to meet at the call of the Auditor at 9:26 A.M.
