Detour for the Bridge Replacement on 200th Avenue

WHEREAS: The Board of Supervisors is empowered under authority of lowa Code Section 306.4

2019 Code of Iowa to operate and manage the Secondary Road System; and WHEREAS: The bridge replacement on 200th Avenue (T-24) approximately 2.5 miles north of Iowa Highway 5 will take more than 48 hours to complete, and Iowa Code Chapter 306.41 requires that a

numbered road have an authorized detour if closed for more than 48 hours; and WHEREAS: The County Engineer recommends closure of the following Road:

200th Avenue (County Highway T-24) 2.5 miles north of Iowa Highway 5

WHEREAS: The County Engineer recommends that the Official Detour be as follows:

From the intersection of 200th Avenue and 497th Street, west and north 1.5 miles on 497th Street to the intersection with 493rd Street; thence west on 493rd Street 0.5 miles to the intersection with County Highway T14; thence northerly 2 miles to the intersection with 477th Street; thence east 2 miles on 477th Street to 200th Avenue (County Highway T-24).

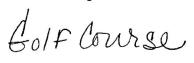
