Harvey motioned to approve the liquor license for The Retreat (pending dram). Seconded by Buban. All voted aye.

Bill Cortesio requested an update on TIF. Kulmatycki stated they are working on the final draft of the urban renewal plan and hope to have it completed this year.

Connie Foster from the City of Exline requested a tax abatement on three parcels totaling \$1,078. The properties are currently owned by a third party. Harvey motioned to table abating taxes until the city can prove possession. Seconded by Buban. All voted aye.

At 9:11 A.M. two bids were opened for local project L-7823A—73-04 to replace a bridge on 210th Ave. lowa Bridge and Culvert submitted a bid for \$158,500. Herberger Construction submitted a bid for \$173,500. Skinner recommended the board reject the bids. It's estimated that it would cost the county \$36,100 for the project to be completed in-house.

Buban motioned to reject the bids from lowa Bridge and Culvert and Herberger Construction. Seconded by Harvey. All voted aye.

Harvey motioned to approve Resolution 2025-35. Seconded by Buban. All voted aye. Resolution # 2025-35

WHEREAS, it has been determined by the Board of Supervisors of Appanoose County, Iowa, that Tax Sale #2010-10313: The East 84 feet of Lots 1, 2, and 3 in Block 20, Of the Town of Dean in Appanoose County, Iowa (Parcel 330283007730000) is no longer needed for the purpose for which it was acquired by the County and it is in the best interest of the county that said property be sold:

- 1. That a public hearing be held September 2, 2025 at 9:10 A.M. in the Appanoose County Courthouse to consider the sale of the above-described property upon motion by Harvey and seconded by Buban.
- 2. That following the public hearing an auction will be held in which the property will be sold to the highest bidder with the county reserving the right to accept or reject any or all bids; who will also pay the current year's taxes, the cost of publication of this notice and the cost of recording the deed.
- 3. That the Appanoose County Auditor is hereby authorized and directed to publish a notice of public hearing on said proposal to convey and sell property no less than four nor more than twenty days prior to that date of such hearing.
- 4. This resolution shall become effective upon its passage and publication. Passed and adopted this 18th day of August 2025.

Buban motioned to accept the 8/5/2025 Sundown Lake RIZ Post Election Audit results. Seconded by Harvey. All voted aye.

Harvey motioned to approve plans for Project No BROS-C004(131)-5F-04 and authorize for lowa DOT letting, December 16, 2025. Seconded by Buban. All voted aye.

There was discussion regarding a project with Cantera. Cantera will blend limestone with Secondary Roads asphalt millings to use in subdivisions. The application is expected to be put down in the spring.

County Engineer, Brad Skinner provided an update to the board. They received notification last week they've been awarded a couple grants totaling \$16,000 that will be used for skid loader attachments for roadside work. They are currently working on soil stabilization projects on 195th and 550th. If this works well, they will look to do more roads. As weather allows, crews are working on ditching and pipes. John Duley is resigning and will be looking for a replacement.
