RULES & REGULATIONS REGARDING
SEWAGE DISPOSAL SYSTEMS CLEANERS
ORDINANCE NO. 4

# SECTION I

The owner of every vehicle used for the purpose of cleaning or disposing of waste removed from sewage disposal systems in Appanoose County, Iowa, shall obtain a written permit annually for each vehicle from the Appanoose County Board of Health. In order to secure a permit, said owner shall provide the following information to the Appanoose County Board of Health:

- A. Full Name
- B. Address
- C. Vehicle Make
- D. Vehicle License
- 'E. Truck Tank Capacity in Gallons
- F. Dumping Site.

The fee for said permit shall be established by the Appanoose County Board of Health in an amount equal to the pro rata actual cost of liscensing.

#### SECTION II

No vehicle used for the purpose of cleaning sewage disposal systems or disposing of waste removed from sewage disposal systems may be operated or used for said purpose in Appanoose County, Towa without first obtaining a permit from the Appanoose County Board of Health.

#### SECTION III

The owner of every vehicle used for the purpose of cleaning sewage disposal systems or disposing of waste removed from sewage disposal systems shall keep the vehicle and equipment in clean, well painted and sanitary condition, and shall have lettered (at least 3 inch high letters), his name, address, and registration certificate number on each truck.

#### SECTION IV

Every vehicle used for the purpose of cleaning sewage disposal systems or disposing of waste removed from sewage disposal systems shall have a tank which is completely enclosed and liquid tight.

#### SECTION V

Any tank used for the purpose of cleaning sewage disposal systems or disposing of waste removed from sewage disposal systems shall be cleaned each day or after being used for the above purposes.

## SECTION VI

Disposal of waste material from private sewage disposal systems.

- A. Sewage waste removed from private sewage systems may be discharged into a municipal treatment plant.
- B. Sewage waste may be spread on farm ground, providing:
  - Farm ground used to grow crops which may be eaten raw by humans, CAN NOT be used for sewage waste disposal.
  - The disposal site must be approved by the Appanoose County Sanitarian before dumping.
  - The disposal site must be a minimum of 300' from any dwelling, well, pond, or drainage ditch.
  - 4. The disposal site must have a percolation rate of 2" in 60 minutes.

#### SECTION VII

Any person who violates any provision of the foregoing rules and regulations of the Appanoose County Board of Health, or any lawful order of said Board, or it's officers, authorized agents or employees shall be fined not exceeding \$100.00 or imprisoned in the county jail not exceeding 30 days. In addition, failure to comply with said foregoing rules and regulations may result in revocation of said permit at the discretion of the Appanoose County Board of Health.

## SECTION VIII

If any section, clause, provision, or part or portion of any section, clause, or provision of this regulation or the application thereof to any person or circumstance is held invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the validity or application of any other section, clause, provision or part or portion of this regulation.
