AN ORDINANCE RELATING TO THE DISPOSAL OF YARD WASTES.

- 1. PURPOSE. The purpose of this ordinance is to provide for the orderly disposal of yard waste; to preserve scarce land available for sanitary landfills through waste reduction; and to provide for the health, safety, and welfare of the people of Appanoose County.
- 2. DEFINITIONS. "Yard Wastes" means: debris such as grass clippings, leaves, garden waste, brush, and trees. Yard waste does not include tree stumps.
 - 3. SEPARATION OF YARD WASTES REQUIRED.
- a. All yard wastes shall be separated by the owner or occupant from all other garbage and refuse accumulated on the premises and shall be composted on the premises or placed in biodegradable bags, containers, or packages and taken by the owner or occupant to the Appanoose County Landfill. If bags are used for the collection of vard waste they must be biodegradable bags as designated by the manufacturer. A hauler shall not collect garbage or refuse unless the yard waste has been separated and disposed of in this manner.
- b. The Appanoose County Sanitary Landfill shall not accept any yard wastes unless the yard waste has been separated from all other garbage or refuse and place in separate biodegradable bags, containers, or packages.
- SECTION 3. REPEALER. All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.
- SECTION 4. SEVERABILITY CLAUSE. If any section, provision or part of this ordinance shall be adjudged invalid or unconstitutional such adjudication shall not affect the validity of the ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.
