

Ordinance No. 32

An ordinance establishing a School Infra-Structure Local Option Sales and Services Tax applicable to transactions within Appanoose County.

Be It Enacted by the Board of Supervisors of Appanoose County, Iowa:

Section 1. School Infra-Structure Local Option Sales and Services Tax. There is imposed a School Infra-Structure Local Option Sales and Services Tax applicable to transactions within Appanoose county.

The rate of the tax shall be one percent (1%) upon the gross receipts taxed under Iowa Code Chapter 422E-School Local Option Tax, in the following: Centerville Community School District, Moravia Community School District, Moulton-Udell Community School District, Albia Community School District, and Seymour Community School District of Appanoose County, Iowa.

The School Infra-Structure Local Sales and Services Tax is imposed on transactions occurring on or after July 1, 2004 through June 30, 2014 within Appanoose County. All persons required to collect state gross receipts taxes shall collect the tax pursuant to Iowa Code Section 422E.3 for School Infra-structure Local Option Sales and Services Tax.

All applicable provisions of the appropriate sections of Chapter 422, Division IV, of the Iowa Code are adopted by reference.

Section 2. Effective Date. This ordinance shall be in effect after its final passage, approval and publication as provided by law.
