

Appanoose County Voting Precinct Ordinance #42

Be it enacted by the Board of Supervisors of Appanoose County, Iowa:

Section 1. Purpose. The purpose of this ordinance is to establish voting precincts for Appanoose County, merging previous precincts.

Section 2. Description.

- a. Combination of existing precincts. Union and Udell precincts will be combined into one precinct which shall be Union/Udell precinct consisting of Union and Udell Townships and the cities of Udell and Unionville.
- b. All other existing precincts shall remain the same:
 - Bellair/Lincoln will consist of Bellair and Lincoln townships and the city of Numa.
 - Taylor/Chariton will consist of Taylor and Chariton Townships and the city of Moravia.
 - Vermillion/Douglas/Sharon will consist of Vermillion, Douglas and Sharon Townships.
 - Pleasant/Franklin will consist of Pleasant and Franklin Townships and the city of Cincinnati.
 - Johns/Independence will consist of Johns and Independence Townships and the City of Plano.
 - Washington/Wells will consist of Washington and Wells Townships and the city of Moulton.
 - Caldwell will consist of Caldwell Township and the City of Exline.
 - Walnut will consist of Walnut Township and the cities of Mystic and Rathbun.
 - Centerville Ward I will consist of northern portion of the City of Centerville beginning W of Hwy 2 to W Van Buren, E to N 7th, N to Washington, E to N 18th, S to E State, E to N 21st, S to E Maple, E to City Limit including annexed Golfview Subdivision.
 - Centerville Ward II will consist of central portion of City of Centerville, all that portion in the center bordered on the N by Ward I and bordered on the S by Ward III using the same city street descriptions.
 - Centerville Ward III will consist of southern portion of City of Centerville, beginning at W edge of Corporation on Star Route to Ontario, E to S 5th, S to W Wall, E to Drake Ave, S to W Terry, e to S 20th, S to E Walden, E to S 21st, S to ACCR RR, follow RR to Corporation Limits.

Section 3. Effective Date. This ordinance shall become effective January 1, 2016.

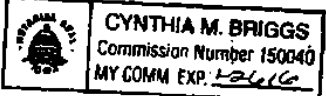
